Ned Seelye underscores the importance of what we do: "Two acute pressures inhibit the growth of global education-a wartime mentality and economic hard times. Since teachers cannot directly affect either, what can we do to help prepare students for the real world-a multicultural planet? The answer is obvious: we can implement a curriculum that enthusiastically acknowledges the polycultural setting of our species." Seelye also says that "understanding the way of life of at least one group of people socialized in another culture is important to survival in a world of conflicting value systems." May our efforts during the ACTFL Year of Languages bear the kinds of fruits that Seelye and the rest of us hope for.

Teacher Vitality Award

Greg Briscoe, Assistant Professor of Spanish at UVSC, is the recipient of the UFLA Teacher Vitality Award. He will use his award to research the role of the Cuban government in cultural expression in Cuba. During a previous visit to Cuba in 2003, Dr. Briscoe made several key contacts in the government and the artistic community, whom he will interview during this visit. He looks forward to deepening his understanding of Cuban culture and society and sharing that knowledge with his students and colleagues. He also plans to make a presentation on his research and experience at the next UFLA conference. which will be held at UVSC in November.

Pat Buckner Award

Alma Sillito Jody Lindsay, Jenna Flood, and Brian Jolley, foreign language teachers at Oak Canyon Junior High School in Lindon, Utah, received the \$500 award to create a mobile foreign language speaking lab, which will be used for verbal assessment for all levels of language students. They have agreed to write an article for the UFLA newsletter in which they will describe their common verbal assessment of over 900 students in 31 different sections and their results.

AN ACTING CURRICULUM FOR TEACHERS OF SPANISH

I am an actor connected with the Marsillach Acting Academy in Madrid. We've experienced considerable success using acting techniques to bring life and immediacy into classrooms of students struggling with a new language. Our experiences have led us to design a curriculum for English-speaking teachers of Spanish. Teacher/participants will perform with professional Spanish actors and receive 45 hours of classroom instruction culminating in a production of Lorca's *Boda de Sangre*.

We are offering our first three-week intensive course this summer. Like any other theatrical endeavor we are starting out on a shoestring. I would very much like to hear from people interested in this approach as well as anyone who has any ideas about the most efficient and cost-effective way to contact others who might be interested. PROPOSED CHANGES IN UFLA BY-LAWS

Members of UFLA are being asked to vote on three proposed changes in the by-laws of the organization. A full description of the changes can be found at http://organizations.weber.edu/ufla/LAWS.HTM but here is a summary of the proposals.

Proposal 1 changes the archaic language in the actual wording of the bylaws to make them easier to read. The proposal reads: Archaic and "lawyerish" language will be removed from Article I, section 1; Art. 1, Sec. 2, Par. B; Art. II, Sec. 4; Article III, Sec. 1; Article III, Sec. 4, Par. B (removed from the By-Laws and moved into policy); Art. VI. Sec 2; Art. VIII. The UFLA board offered no arguments against this proposal.

Proposal 2 changes the wording in the "Purpose" statement of the organization. The proposal reads: Art. I, Sec. 2, Par. A, will be changed so that the Association supports the "learning and preserving of skills in foreign languages, and all languages other than English," rather than the "learning and preserving of foreign language skills. This change reflects the fact that the Association supports all languages which are native to America, including Navajo and ASL, and heritage learners, as well as languages from other lands. Again, the board offered no arguments against this proposal.

Proposal 3 changes the length of office of the UFLA president. The proposal reads: <u>The term of the UFLA President will be changed from one to two years.</u> The terms of the President-Elect and <u>Past President will not be affected.</u> Changes are in Art. III, Section 1, Section 4, Par B, and <u>Section 5</u>) This would affect the terms of the officers as noted below:

- During any given year, there will always be a President and either a Present-Elect or a Past-President, but (generally) not both. Therefore the duties of the President-Elect and the Past-President are the same; only the title is different.
- Elections for President-Elect must be held after each President's first year on the Board as President.
- Elections for Secretary must be held annually.

Arguments for this proposal include:

- The pool for quality presidents is naturally limited. Very few qualified people are willing to have their names put onto the ballot and this will require only ½ the number of presidents over any time period.
- A longer term of service would give continuity to the board and help the president to be more effective once s/he has learned the duties.



• Those serving as "Past-president" have often dropped off the board and not served their term anyway, so by keeping them on as president for an extra year they will be able to accomplish more.

Arguments against this proposal include:

- Requiring a 4-year commitment will further limit the pool of applicants.
- By having the president-elect serve for a year before taking office as president, the continuity is already there.
- If the president decides <u>not</u> to serve the second year and we have no president-elect in place it may cause a greater crisis in leadership.


